OUTDOOR TENNIS FACILITY PROJECT

We are committed to maintaining and enhancing the University of Wisconsin Athletic Department as one of the finest intercollegiate athletics programs in the country by proving the necessary resources for student-athletes to achieve success athletically, academically and socially. Facilities play a key role in recruiting and remaining competitive with other peer institutions.

Project Details

Plans have been developed to expand and improve the Outdoor Tennis facilities at the University of Wisconsin. This needed project will include the following amenities:

- 2 additional outdoor playing courts, bringing the total number of courts to 8 (Optimal for both practice and competition)
- Elevated grandstands to accommodate up to 800 spectators
- Main Scoreboard visible from all courts and stands and individual scoreboards on each court
- Improved entrance gate for fans
- Outdoor lighting, which currently does not exist
- Opportunity to host additional home matches and other special tournaments
- Total project cost is \$2 million
- Construction began in June, 2018 with a targeted grand opening fall of 2018

Request for Support

The Outdoor Tennis facility project will not be possible without private support and generous gift commitments. We are happy to share that \$1,500,000 in gifts have been made as of June 2018, which leaves \$500,000 remaining to fund this project. Gifts can be pledged over a 5-year period and are 100% tax deductible.

Donor Recognition Opportunities

Individual donor recognition opportunities are available for leadership level gifts of \$50,000 or more to this project. Potential recognition opportunities include:

- Individual Court Naming (4 of 8 courts available for naming)
- Main Scoreboard
- Grand Stands

All gift commitments of \$5,000 or more will be recognized on a Donor Wall of Honor located at the facility.

Contribution Information

Tax

Deductibility

Contributions made in support of the athletic department's facility projects are considered charitable gifts to the University of Wisconsin Foundation and are deemed 100% tax deductible. The UW Foundation will issue a tax receipt to the donor each year.

Pledges

Contributions made in support of the athletic department's facility projects can be pledged over a five-year period.

Gift Methods

Contributions made in support of the athletic department's facility projects can be made in one of three methods:

Check made payable to UWF - Tennis Facility Fund

Credit Card (American Express, Discover, MasterCard, Visa)

Appreciated Securities - The amount of the mean market value of a listed security on the date it passes unconditionally to the UW Foundation will count as your gift. A gift of long term appreciated assets entitles you to an income tax charitable contribution deduction equal to the fair market value of the securities on the date of your gift. You may also avoid capital gains tax on any appreciation of those securities.

Annual Fund

Annual contributions to the athletic department's facility projects are recognized within the Wisconsin Athletics annual giving program and subsequently earn Wisconsin Athletics Priority Points. Please note contributions made in support of the athletic department's facility projects may not replace annual contributions associated with season ticket benefits due to IRS tax regulations. Donors are encouraged to make contributions prior to April 20 each year to ensure priority for all benefits.

Recognition

Individuals who make a leadership level contribution in support of a facility project may have the opportunity to select an individual recognition opportunity. Naming recognition will remain in the facility as long as the facility exists in its current design. UW Athletics will follow up with each donor during the final construction phase of that project to confirm recognition details.
